- 1. Applications, drawings, plats, pictures, etc., must be submitted in duplicate. Upon Architectural and Environmental Preservation Committee action, one copy of all materials submitted will be returned to the applicant.
- 2. Drawings must be to scale.
- 3. Provide all dimensions, including height, roof slope, etc., on new construction.
- 4. Certified plats will be required for new construction, including additions to a present structure, new structures on the lot, fences, etc. Area of proposed construction must be indicated on the plat. Plats are not required for paint changes, storm windows, or other such modifications.
- 5. Provide a list of all materials to be used in the proposed construction.
- 6. Present colors or any proposed colors must be indicated. Applications for colors which are not the original colors must be accompanied by actual color samples, not photographs of colors.
- 7. Changes in grade or other conditions that will affect drainage must be indicated. Applications may be disapproved if adjoining properties are adversely affected by drainage changes.
- 8. Concurrence of adjoining lot owners may be sought by the Architectural and Environmental Preservation Committee under certain circumstances.
